Application range For interior and exterior use on teak wood.

Technical qualities Free of cobalt. Removes light soiling, refreshes and highlights the structure of the wood grain. After

complete drying water-repellent and does not form a layer. Without UV protection.

Full declaration Isoaliphates, linseed oil, linseed oil - stand oil - natural resin ester, and drying agents free of lead (Mn, Zr).

Colors Clear to slightly honey-colored (Gardner color index: approximately no.5)

Application method Put some Teak Oil on a cloth and rub on sparingly, i.e. very thinly, in the direction of the wood grain.

Polish after 30-60 minutes. Surface should not be sticky anymore, otherwise apply again a few drops and polish until it is no longer sticky. For heavier soiling give 10 – 20 minutes to react, remove with dirt and then apply sparingly. Always do a test application on an inconspicuous area to ensure compatibility e.g.

with previously used oils.

Coverage First coat: 1 liter (1.06 quart) is sufficient for approximately 30 m² (323 ft²), i.e. 30ml/m².

Second coat: 1 liter (1.06 quart) is sufficient for approximately 84 m² (904 ft²), i.e. 12ml/m². Could be considerably less or more, depending on the condition and the absorbency of the surface.

Test application!

Drying time At 23 °C (73 °F) and 50% relative humidity: approximately 8 - 16 hours under good light- and ventilation

conditions.

Specific gravity Approximately 0.84 g/ml.

Safety advice Refreshment with ALIS Teak Oil once the wood is dry.

Plant oil based products often lead to drying delays due to a lack of oxygen and light. This can result in

long lasting oil smell. Apply only one sparing coat and leave the cabinet door open for one week.

If the stain drips off or bubbles appear during application, an incompatibility exists through the pre-

treatment or it has been sanded to smooth. Coarser sanding may possibly create remedy.

Always be sure to store and then dispose of cleaning cloths, polishing pads, sponges, etc. that are still wet or even slightly moist with ALIS Teak Oil No. 567 in an airtight metal container or in water, as there is a danger of spontaneous combustion caused by the plant oil content. The liquid or applied product is not

self-ignitable.
